Calling all stations, calling all stations. This is (your call sign). I will be net control for this Thursday evening session of the Jackson County Amateur Radio Emergency Service Training Net.

Is there any emergency or priority traffic for the net at this time? (Break)

My name is (your name) and I am located in (your town) Alabama. This net was formed to support the public safety of Jackson County Agencies in response to severe weather or civil disaster situations. This net will use the 146.90 repeater with a 123Hz tone. In the event this repeater goes down we will use the output frequency, which is 146.90. The purpose of this training net is to practice net operations, checking equipment, and improving our skills in handling traffic. (Break)

Is there any station that can act as back up net control in case this station goes off the air for any reason?

Confirming (their call sign) as Backup net control station.

I ask that the Backup net control station maintain a log of check ins and any traffic.

Is there any station that can act as a SKYWARN liaison during a weather event, which can monitor this frequency and the 147.09 repeater with a tone of 203.5Hz to relay any weather reports to the SKYWARN Emergency Net?

Confirming (their call sign) as SKYWARN liaison station.

During an actual emergency this net would be activated as the Jackson County Emergency Net. Is there a station that can be a liaison For the Alabama Traffic Net Mike which is part of the ARRL National Traffic System and the Alabama Emergency Net System on the frequency of 3965 kHz? (3.965 MHz)

Confirming (their call sign) as Alabama Traffic Net Mike liaison station.

This session will begin with check-ins from participating stations, followed by News and Announcements. The patience of all non-participating stations during this training session is greatly appreciated. This training session will be conducted as a directed net. All traffic is to be directed through the Net Control Operator. Check-ins will be taken in the order received. Net Control will <u>confirm</u> call sign, name, and location. When you check in, I ask that you check in slowly and clearly, give your call sign phonetically, your name, your location and whether or not you have any traffic for this net. (Break)
